The sale of each individual SADDLE VENT® device by AIR SYSTEMS, INC., dba AIR SYSTEMS INTERNATIONAL, INC. and limited title to each individual SADDLE VENT® device is conditioned upon compliance with the restrictions set forth herein. Only a person or entity that orders and obtains a SADDLE VENT® device directly from AIR SYSTEMS INTERNATIONAL, INC. may sell the particular device ordered and obtained directly from AIR SYSTEMS INTERNATIONAL, INC., subject to these terms and conditions. Any sale, offer for sale, lease and/or use of a particular SADDLE VENT® device in conflict with the forgoing violates the terms of sale by AIR SYSTEMS INTERNATIONAL, INC. (absent the express written advance consent of AIR SYSTEMS INTERNATIONAL, INC. for the particular device), and infringes upon the intellectual property and other rights of AIR SYSTEMS INTERNATIONAL, INC. Purchase(s) from other than AIR SYSTEMS INTERNATIONAL, INC of a SADDLE VENT® device (or more than one device) carries no license from AIR SYSTEMS INTERNATIONAL, INC. to the associated patent, trademark and other rights, so that offering same for sale or resale constitutes willful infringement of the rights of AIR SYSTEMS INTERNATIONAL, INC.
