


OPERATING INSTRUCTIONS AND REPLACEMENT PARTS



Set-up/Operation



STEP 1)

Mount the remote alarm in desired location and connect 120 VAC to audible alarm/strobe. Black - 120 VAC line, white - 120 VAC neutral, green - ground. Alarm is factory set at high dBA output with a continuous tone. Remove audible alarm from enclosure to set different alarm tones and to set volume at standard dBA if desired. See page 3 for alarm tone options.

NOTE: When mounting outdoors, mount in a vertical position as shown. Audible alarm cover is louvred to keep rain from entering the audible alarm enclosure.

STEP 2)

Turn on the electrical device that will be sending the 120 VAC signal to the remote alarm.

STEP 3)


Place the electrical device in alarm mode. Audible alarm and strobe should be active. Remote alarm is now operational.
